





The Central Drugs Standard Control Organization (CDSCO) is India's national regulatory authority for pharmaceuticals, medical devices, and cosmetics. It is responsible for ensuring the safety, quality, and efficacy of these products in the country

MD5 License

- License to Manufacture Class A and **Class B Medical Devices**
- Takes 2-3 Months

MD15 License

- License to Import Medical Devices
- Takes 5-6 Months

MD9 License

- License to Manufacture Class C and **Class D Medical Devices**
- Takes 3-4 Months

Class A Registration

- Registration to Manufacture or Import Class A Non Sterile Non Measuring Devices
- Takes 1 Day
